

**Lexus VIP Fan Experience Sweepstakes
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE STATE OF NEVADA AND WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS INTENDED FOR ENTRY IN THE STATE OF NEVADA ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE STATE OF NEVADA AT THE TIME OF ENTRY.

DATES OF SWEEPSTAKES: The “Lexus VIP Fan Experience” Sweepstakes (the “Sweepstakes”) starts on November 30, 2024 and ends on January 30, 2025 (the “Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open only to legal residents who reside within a seventy-five (75) mile radius of T-Mobile Arena, and are at least eighteen (18) years of age at time of entry (each, an “Entrant”). Officers, directors, managers and employees of Southern Nevada Lexus Dealers (the “Sponsor”), Toyota Motor Sales USA, Inc., and each of their respective parent companies, subsidiaries, affiliates, and related companies, dealers, dealership associations, advertising and promotion agencies, consultants and agents, as well as the immediate family (spouse, parents, siblings and children) and household members of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes, including National Sweepstakes Company, LLC (the “Independent Administrator”) are not eligible to participate. Sweepstakes is subject to all federal, state and local laws and regulations. Vegas Golden Knights are not a sponsor of this Sweepstakes. Sweepstakes is void outside the state of Nevada and wherever else restricted or prohibited by law. Persons who have previously won a contest, sweepstakes or promotion of any kind sponsored or otherwise associated with Sponsor or Toyota Motor Sales, U.S.A., Inc. within twelve (12) months immediately preceding the start of this Sweepstakes are ineligible to participate or win.

HOW TO ENTER: There are two (2) ways to enter the Sweepstakes:

ONLINE ENTRY: Visit <https://www.nhl.com/goldenknights/fans/lexus-vip-fan-experience> (the “Website”) during the Sweepstakes Period, click on the Sweepstakes image and complete the official entry form (the “Entry Form”) in its entirety including your first name, last name, address, city, state, zip code, email address (not required), telephone number and date of birth. Then, click the “Submit” button in order to receive one (1) entry into the Sweepstakes.

ONSITE ENTRY: Visit the T-Mobile Arena (located at 3780 S Las Vegas Blvd, Las Vegas, NV 89158) at the Lexus Plaza Activation during the Sweepstakes Period and complete the official entry form (“Entry Form”) which is made available via an electronic tablet, provided by a product specialist. The Entry Form must be completed in its entirety including your first name, last name, zip code, email address, and phone number. Upon completing the Entry Form, touch the “Submit” button in order to receive one (1) entry into the Sweepstakes. The Lexus Plaza Activation will be onsite during the following Vegas Golden Knights home games:

Limit of one (1) entry per person/email address for the entire Sweepstakes. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant’s entry and that Entrant may be disqualified from the Sweepstakes. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the person in whose name and email address were submitted (“Authorized Account Holder”). Entrants may be required to provide proof of being the Authorized Account Holder. If the Sponsor cannot determine the identity of the person based upon the information submitted via the Entry Form, the respective Entrant will be disqualified. No mechanically or programmatically reproduced entries are permitted. Sponsor will not verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged entries. By entering, each Entrant; (a) represents that he/she is at least eighteen (18) years of age and otherwise eligible to participate in the Sweepstakes; and (b) fully and unconditionally agrees to and accepts these Official Rules and the decisions of Sponsor, which are final and legally binding in all respects. Any person who tampers with the entry process in any way will be disqualified.

WINNER SELECTION/NOTIFICATION: On or about February 3, 2025, one (1) prize winner (the “Prize Winner”) will be selected at random from among all eligible entries received during the Sweepstakes Period. Odds of winning the Prize are dependent upon the total number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by a Sponsor representative whose decisions are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects.

Potential Prize Winner will be notified by a Sponsor representative via email or phone immediately following the drawing. Sponsor representative will make one (1) attempt to reach the potential Prize Winner (“Notification”). In the event that the potential Prize Winner does not respond to any such Notification within twenty-four (24) hours of the time of issuance or declines the Prize for any reason, or if it is determined by the Sponsor in their sole discretion that the potential Prize Winner is not eligible in accordance with these Official Rules, the potential Prize Winner will be disqualified and an alternate Prize Winner may be selected from among the remaining non-winning eligible entries received during the Sweepstakes Period, time permitting. Once verified via the Notification, the potential Prize Winner will be required to complete and return “Required Documents” as further described in the “PRIZE CLAIMS” section below. Prize will be awarded to the Prize Winner upon receipt and confirmation of the “Required Documents”.

PRIZES: Prize Winner will receive a prize consisting of: i) coach class roundtrip airfare for Prize Winner and one (1) Guest to/from a major airport nearest the Prize Winner’s residence and Nashville, TN, ii) two (2) night hotel accommodations from March 28, 2025 to March 30, 2025 at a hotel to be determined by the Sponsor (one (1) room double occupancy), and iii) and two (2) Lexus Club tickets to the 2025 Golden Knights away game located in Nashville, TN on March 29, 2025 (the “Prize”). Total approximate retail value of the Prize is \$3,000.

Trip, travel, and lodging elements may be subject to change due to impracticability or unavailability, or for any other reason as determined necessary by Sponsor or its designee. Tickets are subject to the terms and conditions of issuer and will not be replaced if lost, stolen, misplaced, damaged or destroyed. ARV may vary, depending on the point, date and time of departure. Prize must be accepted as a whole or will be forfeited in its entirety. All travel arrangements must be made through a travel agent or entity selected by Sponsor. No changes will be made to travel details once any element(s) of the travel arrangements have been booked. No frequent flier miles will be earned on any element of prize travel. Prize conditions may be added or modified by Sponsor or its designee. Sponsor or Independent Administrator are not responsible for any changes of any element of the Prize, nor are they liable for any expenses incurred as a consequence of flight/event changes, cancellation or delays. Prize Winner or Guest later found ineligible or non-compliant will be immediately required to return and forfeit any prize awarded. In the event Prize Winner and/or Guest engage in behavior that, as determined by Sponsor (or its designee) in their absolute discretion, is obnoxious or threatening, dangerous, illegal or that is intended to annoy, abuse, threaten or harass any other person, or may cause harm, property damage or any other loss, Sponsor reserves the right to terminate the trip early, in whole or in part, and to send the Prize Winner and Guest home with no further compensation.

The Prize Winner will be contacted by a Sponsor Representative regarding his/her/their Prize. Prize Winner must be available to attend the Vegas Golden Knights home game associated with the Prize, or Prize Winner will be disqualified and an alternate Prize Winner will be selected, time permitting, even if the disqualified potential Prize Winner’s name may have been publicly announced. **Prize Winner is solely responsible for all federal, state, and local taxes and all other expenses not specifically mentioned herein, including any additional transportation, parking, accommodations, meals, and beverages, incidental expenses and gratuities.** No substitution or cash redemption of prize is permitted. No responsibility is assumed by the Sponsor for any cancellation or rescheduling of any prize related event in whole or in part. In the event of cancellation or rescheduling no alternate or substitute prize for such cancellation or rescheduling will be awarded. Prize is not transferable and may not be resold. Sponsor reserves the right to substitute a prize of equal or greater value if Prize becomes unavailable due to reasons beyond the control of the Sponsor.

Vegas Golden Knights game tickets and admission to the Arena are subject to all security, fan conduct, safety, and health requirements and policies put in place by Vegas Golden Knights and its affiliates and subsidiaries, the NHL and its affiliates and subsidiaries, and Arena including requirements relating to face masks and enhanced health screenings as they may be updated from time to time. Prize Winner and Guest must also comply with all applicable ticket terms and conditions and all applicable laws, policies, orders, ordinances, protocols, and guidelines issued by federal, state, and local authorities respecting any pandemic or any other communicable diseases, and attendance at the Arena is conditioned on such compliance.

No more than the number of prizes as set forth in these Official Rules will be awarded. The difference in value of the Prize as stated herein and value at time of notification, if any, will not be awarded.

Sponsor reserves the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Sponsor reserves the right to disqualify or reject any incomplete, inaccurate or false entry. **ANY ATTEMPT BY ANY PERSON TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAW, AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. SPONSOR'S FAILURE TO ENFORCE ANY TERM OF THESE OFFICIAL RULES SHALL NOT CONSTITUTE A WAIVER OF THESE PROVISIONS.**
