## "Lexus Ultimate Date Night at the Altria Theater" Sweepstakes

## **OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE STATE OF VIRGINIA AND WHERE PROHIBITED OR RESTRICTED BY LAW. **DATES OF SWEEPSTAKES**: The "Lexus Ultimate Date Night at the Altria Theater" Sweepstakes (the "Sweepstakes") begins at 12:00 a.m. Eastern Time ("ET") on April 26, 2024 and ends at 11:59 p.m. ET on May 24, 2024 (the "Sweepstakes Period").

Then, click the "Submit" button in order to receive one (1) entry into the Sweepstakes. **There is a limit of one (1) entry per Entrant during the Sweepstakes Period.** 

Neither Sponsor nor any Sweepstakes Entity is responsible for any entry that is lost, late, garbled, stolen, delayed, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.
