

Lexus "Best Seats in the House" Sweepstakes

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE STATE OF VIRGINIA AND WHERE PROHIBITED OR RESTRICTED BY LAW. THIS SWEEPSTAKES IS INTENDED FOR ENTRY IN THE STATE OF VIRGINIA ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED WITHIN THE STATE OF VIRGINIA AT THE TIME OF ENTRY.

DATES OF SWEEPSTAKES: The "Lexus Best Seats in the House" Sweepstakes (the "Sweepstakes") begins at 12:00 a.m. Eastern Time ("ET") on March 4, 2025 and ends at 11:59 p.m. ET on April 25, 2025 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open only to legal permanent residents of Virginia who live within a 75-mile radius of the Altria Theater ("The Sweepstakes Administrator", located at 6 N Laurel St, Richmond, VA 23220), who are eighteen (18) years of age at time of entry (each, an "Entrant"). Officers, directors, managers and employees of Eastern Area Lexus Dealer Advertising Association, Inc. (the "Sponsor"), Toyota Motor Sales U.S.A., Inc., Altria Theater, Saatchi & Saatchi North America, LLC, and each of their respective parent companies, subsidiaries, affiliates, and related companies, dealers, dealership associations, advertising and promotion agencies, consultants and agents, as well as the immediate family (spouse, parents, siblings and children) and household members of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes, including the Sweepstakes Administrator are not eligible to participate. HOW TO ENTER: To enter, visit altriatheater.com/lexus-sweepstakes (the "Website") during the Sweepstakes Period and complete the official entry form (the "Entry Form") in its entirety, including your first name, last name, address, city, state, zip code, email address, telephone number where you can be reached for potential prize winning notifications (including area code), if selected, and date of birth. Then, click the "Submit" button in order to receive one (1) entry into the Sweepstakes. **There is a limit of one (1) entry per Entrant during the Sweepstakes Period.**

Neither Sponsor nor any Sweepstakes Entity is responsible for any entry that is lost, late, garbled, stolen, delayed, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different identities, and/or any other methods will void that Entrant's entry and that Entrant may be disqualified from the Sweepstakes. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the person in whose name and mailing address were submitted via the Entry Form (the "Authorized Account Holder") and such Authorized Account Holder must comply with these Official Rules. The potential Grand Prize Winner may be required to show proof of being the Authorized Account Holder. If the Sweepstakes Administrator cannot determine the identity of the person based upon the information submitted via the Entry Form, the respective Entrant will be disqualified. No mechanically or programmatically reproduced entries are permitted. Sponsor will not verify receipt of entries for Entrants.

WINNER SELECTION/NOTIFICATION: On or about April 27, 2025, one (1) potential prize winner (the "Prize Winner") will be selected at random from among all eligible entries received during the Sweepstakes Period. Odds of being selected as the potential Prize Winner are dependent upon the total number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by the Sweepstakes Administrator whose decisions are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects.

The potential Prize Winner will be notified by a representative of the Sweepstakes Administrator via email within twenty-four (24) hours of the random drawing (the "Notification"). One (1) attempt will be made to reach the potential Prize Winner via the Notification. If Potential Winner cannot be contacted, or if Sweepstakes Administrator does not receive a response from the potential Prize Winner within seventy-two (72) hours of the Notification from Sweepstakes Administrator, then the Prize will be forfeited. If Potential Winner does not complete and submit all documents required by the Sweepstakes Administrator within five (5) days of being notified of winning, then the prize will be forfeited.
